**CHISHOLM-HIBBING AIRPORT AUTHORITY**

- The purpose of the Airport Authority is to provide airport-planning services to the Chisholm-Hibbing Airport.
- 6- member Board (3 from Hibbing, 3 from Chisholm)
- One (1) three-year term vacancy ending December, 2021
- Must be resident of the City of Hibbing

**FIRE FIGHTER CIVIL SERVICE COMMISSION**

- The purpose of the Civil Service Fire Fighter Commission is for selection and promotion of Public Safety personnel under the authority of MN Statutes Chapter 419 and amendments thereto.
- The Fire Fighter Civil Service Commission consists of 3 members appointed by the city council to three-year terms. Board Members must be residents of the City of Hibbing.
- Meetings are held as needed.
- One (1) three-year term vacancy ending March 31, 2022

**POLICE CIVIL SERVICE COMMISSION**

- Purpose of the Police Commission is for the selection and promotion of Public Safety personnel under the Authority of [MN Statutes Chapter 419](#).
- The Police Commission Consists of 3 members appointed by the City Council to three- year terms
- Meetings are held as needed
- One (1) Three-year term vacancy beginning April 1, 2018 and ending March 31, 2022

**PLANNING COMMISSION**

- Purpose of the Commission is to oversee the City Land Use Ordinance and provide land use recommendations to the City Council.
- Supported and advised by a full-time City Staff.
- 7- member Commission
- Meets twice monthly (2<sup>nd</sup> and 4<sup>th</sup> Monday)
- 2 - Completing 3-year term vacancies (Expire March 31, 2020)
- 2 - 4-year vacancies (Expire March 31, 2023)
- 1 – 3-year vacancy (Expires March 31, 2022)

#### **HERITAGE PRESERVATION COMMISSION**

- Purpose is to safeguard the heritage of the City by preserving sites and structures which reflect elements of the City's cultural, social, economic, political, visual, or architectural history.
- Meets as needed
- 7-member Commission
- One (1) 2-year term vacancy (Expires April, 2020)
- Two (2) 3-year term vacancy (Expires April, 2021)
- One must be on the current Planning Commission

#### **HUMAN RIGHTS COMMISSION**

- Purpose is to secure for all citizens freedom from discrimination because of race, color, creed, religion, national origin, sex, marital status, disability, status with regard to public assistance, sexual orientation, and age.
- 6-member Commission
- Complete Two (2) 3-year term vacancies (Expiring March 31, 2020)
- Complete Two (2) 3-year term vacancies (Expiring March 31, 2021)
- Two (2) 3-year term vacancies (Expiring March 31, 2022)
- Must be a resident of the City of Hibbing

#### **GAMBLING COMMISSION**

- Purpose of the Gambling Commission is to prepare and recommend changes in procedure and practice governing charitable gambling in the City, and to make recommendations with regard to possible changes in City Code provisions governing charitable gambling in the City
- 3-member Commission
- Meets as needed
- One (1) 1-year term vacancy (expiring March, 2020)
- One (1) 2-year term vacancy (expiring March, 2021)
- One (1) 3-year term vacancy (expiring March, 2022)

#### **HIBBING PUBLIC UTILITIES COMMISSION**

- Purpose of the Public Utilities Commission is to develop policy and oversee management of the City of Hibbing Public Utility System.
- 5-member Commission
- Complete Two (2) three-year term vacancies (Expiring March 31, 2022)

#### **HIBBING HOUSING AND REDEVELOPMENT AUTHORITY (HRA)**

- Purpose of the Housing and Redevelopment Authority (HRA) is to administer the low rent public housing program for the City of Hibbing. The HRA also acts in a redevelopment role by acquiring underutilized or blighted property and preparing them for reuse in the community5-member Authority
- Meets last Tuesday of the month
- One (1) 5-year term vacancy (expiring March, 2022)
